SHAW DOG PARK: RULES AND REGULATIONS

<ul style="list-style-type: none"> €No vicious dogs allowed. All fights between dogs must be attended to by owners of the dogs €Children under 12 not allowed in fenced area, and children under 18 must be accompanied by a responsible adult over 18. €Hours: Daily from 6am - 10pm; be considerate of neighbors, unruly behavior is forbidden €Owners are legally responsible for their dogs and any injuries or damage caused by them. €Dogs must have proof of rabies vaccination, or approved titers, from a veterinarian. €Pick up your dog's poop! €Leash laws apply outside the fenced area. €Owners <u>must</u> be inside the fence area at all times while their dogs are at play. No dog is to be left at the dog park unattended - no exceptions! €Gates must be closed except when entering/exiting. 	<ul style="list-style-type: none"> €Dogs must wear membership tag on their collars. €Absolutely NO choke, pinch or spike collars allowed. Dogs <u>must</u> wear a smooth cloth band or leather collar while in dog play area. €Dogs to be under reasonable voice control. €Limit – 3 dogs per person. €Do <u>not</u> leave any cigarette butts or trash at the dog park. €Not allowed in dog play area: <ul style="list-style-type: none"> •dogs in heat •vicious dogs •animals other than dogs •glass of any sort •puppies under 4 months old •dogs that are ill or injured •food or treats for people or dogs •bikes, roller blades, scooters, or other motorized devices

All memberships are subject to review by the board in the event of: a written complaint regarding either an owner's or dog's behavior or a repeated disregard for the dog park rules. *All members are encouraged to question visitors without current park tags, or speak up regarding people who are not respecting the dog park. Waiver & Release of Liability

By entering this park I agree to indemnify, defend, and hold harmless the City of St. Louis ("City"), Land Reutilization Authority ("LRA"), Flora Place Association ("FPA"), Shaw Neighborhood Improvement Association ("SNIA"), and its officers, agents, and employees from any and all lawsuits, damages, claims, judgments, loss, liability, or expenses arising out of 1) any death or personal injuries or property damage which I may sustain or which I or my animal may cause while I am using this park or any equipment owned by or under the control of the City, LRA, FPA or SNIA, or while participating in any activity sponsored by the City, LRA, FPA or SNIA, or 2) any death or injury which results or increases by any action taken to medically treat me. The terms above shall apply whether or not the alleged injury is also caused by or arises out of any dangerous condition of property, or the alleged negligence or any acts or omissions of the City, LRA, FPA or SNIA, or its officers, agents, or employees.

It is my understanding that no agent of the City, LRA, FPA or SNIA will supervise the off-leash area at any time.

I also understand that the City, LRA, FPA or SNIA does not carry insurance to cover users of this park, I understand there are risks associated with this park, and I assume the risk of any injuries that my animal or I may sustain at this park.

That the owners of all dogs utilizing said Shaw Dog Park shall display all appropriate tags including membership tag issued to owners, as well as the dog's current rabies tag.

I have carefully read this release of liability, understand, and fully agree with its contents. I also have received a copy of the brochure outlining rules for use, etiquette for dog owners and recommendation for dog owners.

This is a release of liability. Do not sign if you do not understand or do not agree with its terms. Any dog owner/handler using the park must sign this waiver. IF THE APPLICANT HAS NOT ATTAINED THE AGE OF LEGAL MAJORITY [18], THE SIGNATURE OF PARENT OR GUARDIAN SHALL ALSO BE REQUIRED.
